SPIRAL TRIBE,

In court on charges relating to 1992's Castlemorton rave, are setting up a sound systems 'union' to combat the new wave of government legislation.

At the beginning of a crucial year both for the rave scene and the travellers' way of life, the maverick rave co-operative have insisted that united action by organisers of free festivals and raves is vital.

The newly formed Advance
Party network will be a crucial
tool to help the rave scene
fight the "oppressive
legislation" included in the
Criminal Justice bill, by
improving sound systems' legal
knowledge and increasing
communication and cooperation between systems,
say The Tribe.

The bill – which threatens to outlaw the travellers' way of life and crush raves and unlicensed free festivals – goes for its second reading in the House of Commons on January 11. If successful in the Commons, the laws could be in place by this summer.

Besides outlawing the travelling community, the law changes would give police the power to:

- Arrest ravers who refuse to leave a night-time rave site.
- of land, including minor roads and common land, if they have brought more than six vehicles onto it against the owner's will.
- Confiscate vehicles and sound equipment and charge for their return.

Liberty, the civil rights campaigning body, insist that at least part of the new legislation contravenes the right to assemble and the freedom of expression provisions, as laid down in the European Bill Of Human Rights.

But besides opposing the legislative changes – which would largely formalise actions which the police have already been taking in 1992/'93 – Spiral Tribe say the rave scene could give itself more

ammunition when faced by police obstruction by banding together and helping to spread information and advice about sound systems' rights as well as possible loopholes in the law.

A Tribe member told the NME: "We've had offers of help from several solicitors already, who have offered their services for free to train one person from each sound system as a legal observer, who knows their rights if they get stopped at a police road-block or wherever."

Many of the major techno sound systems, including the Tribe, Bedlam, Vox Popull, Shush Man Crew, Ooops. Chillum Tribe, Safe And Sound, Circus Lunatic, Full On and Asylum, have all joined and more are expected to help with fund-raising raves to raise cash for the cause. The Tribe say: "On a more basic level, it's a way for people from different sound systems to get together and start talking to each

other."

Liberty's legal director David Wadham, who has spent time as a legal observer with a sound system, fully supported the scheme. "In the past, the police have been able to exceed and abuse their powers because people haven't known their rights.

"People need to have somewhere to settle and have parties. There will continue to be conflict between ravers and the police – this law won't change that."

News of the 'union' comes
just a few days before 12
people, who are alleged to be
the members of the Spiral Tribe
and Bedlam sound systems,
are due to stand trial at
Wolverhampton Crown Court
on Monday (January 10)
accused of causing "public
nuisance" by organising the
Castlemorton rave in May
1992. The defendants – who all
deny the charges – could face
life imprisonment if found
guilty.

The case, which is due to last four months, is expected to cost the taxpayer £4m, a waste of taxpayers money, say Liberty. It will simply add to the millions already spent during 1993 on a series of police crackdowns on sound systems, which wiped all but a handful of small events across the country.

The most high profile clash was the £500,000 police operation which blocked a 50 caravan travellers convoy on the M5 to prevent the traditional Avon Free Festival in May.




Was that DJ George we saw dancing in his usual groovey manner then quickly running outside for a honk only to be there, on the floor, two minutes later casually wiping his mouth with

hold of test-pressings to a crowd wanting to escape the cheesey smells emitting fron Oz's set next door.



# Ecstasy a soft drug says Spanish court

Serials are alarmed at a weekend ruling by a high court judge in Madrid which defines ecstasy as a soft and non-addictive drug which does not damage health.

The ruling came at the trial of three men accused of trafficking the popular "designer drug", and means that they now face only five-year sentences and fines of 50 million pesetas (about £250,000). Prosecutors had sought the 11-year sentences and higher fines prescribed for dealing in hard drugs.

Spain's penal code differentiates between soft drugs—such as marijuana or hashish—and hard drugs, which include heroin, cocaine, amphetamines and, until now,

ecstasy.

The four defence lawyers assembled a team of expert witnesses, several from the United States, who stated that ecstasy, a cocktail of chemicals known as MDMA, was different from a similar drug, MDA, commonly known as "the love pill", which has dangerous side effects.

They said MDMA was not hallucinogenic but "accentuates visual, tactile and aural senses and produces a sense of well-being and greater

empathy.

"It is not known to cause physical or mental dependence, and its effects only last for two to three hours."

Their controversial evidence contradicts other medical experts who believe that long-term use of ecstasy has psychological side-effects and causes dependence.

Ecstasy first appeared in Spain in the 1970s, particularly on the island of Ibiza, where it became popular in

tourist discotheques.

The drug became more freely available and is widely taken by young people embarking on the "bakalao route", a binge beginning in Madrid and other big cities on Friday nights and continuing through the weekend to throbbing bakalao music.

It often takes the form of a pub crawl which involves driving at breakneck speeds along main roads and ending in bars on the Mediterranean coast. Many of the weekend road accidents in Spain involve young people.


Drugs, both hard and soft, are openly sold in and around bakalao bars but most of the young people who take part in the raves


say they prefer ecstasy.

It now appears that what they have been taking could have been MDA.

"It is important to be aware that what is sold as ecstasy on the bakalao routes is often not that drug and could be more dangerous," said Jaime Sanz de Bremond, the main defence lawyer.

The prosecutor in the case intends to appeal to Spain's supreme court. He is certain to be supported by the interior ministry's anti-drug campaign.

OBODY knows how many people in Britain are living semi-legally on someone else's property, but they probably number over 100,000. They include gypsies in trailer caravans, "New Age travellers" in buses, lorries or bender tents, squatters in some of the million or so empty or derelict buildings throughout the country and street-dwellers sleeping in shop-fronts and cardboard boxes.

They are an embarrassment to a Government that would like to portray its policy of stimulating the economy by cutting public services as a success. The Government's response has been a campaign of vilification, highlighting instances of anti-social behaviour and trying to whip up hysteria about cultural deviance. The tone was set by Margaret Thatcher in 1986 when she referred to New Age travellers as "a horde of medieval brigands".

This campaign has culminated in the Criminal Justice and Public Order Bill which received its first Commons hearing last week. Among its 117 separate clauses are some specifically targeted at gypsies, travellers and squatters; others are designed to restrict people's rights to demonstrate. All of them focus on protection of property and involve criminalisation of trespass.

For over 800 years, trespass has been a civil offence in Britain. It is recognised as a dispute between individuals rather than as a crime against society. Thus it has never been a crime to walk on other people's land nor even to enter their house. It does remain a crime to break and enter, to commit a breach of the peace or to commit damage to their property; a road protester was arrested recently for "damage to a piece of string".

To those who value the institution of private property there may appear to be merit in the measures that the Criminal Justice Bill will introduce. Is there not a strong case for strengthening property rights to enable householders to bypass the lengthy legal procedure presently necessary to eject squatters?

However, the complicated common law relating to trespass, which

allows trespassers certain leeway, has not endured since pre-Medieval times without good reason. It takes into account two fundamental facts. The first is that everybody has to be somewhere — and it is in the interests of everyone that "somewhere" is not prison. The second is that everywhere is someone's property. More than half of all private land in Britain is owned by 1 per cent of the population, and three quarters by about 5 per cent. So-called public land is owned by bodies such as county councils, district councils, highway authorities, the Forestry Commission and the Crown, all of whom can act as owners against trespassers. Customary recognition of certain spots as stopping places for gypsies and travellers was omitted from the 1965 Commons Registration Act. Thousands of people now have nowhere to go.

In the absence of legislation guaranteeing have-nots some access to land, the existence of a legal grey area surrounding trespass has been essential in providing a legal "stopping place" where they could stake

out a temporary claim.

The new proposals go a long way towards making the simple act of being on someone else's property an imprisonable crime. Among the Bill's provisions are these:

• Squatters and occupiers claiming tenancy who fail to leave a building within 24 hours of application to the courts by the owner will be commit-

ting a criminal offence.

• Public assemblies of trespassers who fail to comply with a police request to leave will be committing a criminal offence.

Police will have the power to order trespassers to leave "if they seek to disrupt or prevent a lawful activity by the owner or his guests". Lying in front of a bulldozer will become a criminal offence.

The police will have powers to move from private land any gathering of more than six vehicles, to impound the vehicles (even if they are someone's home) and to demand

cash for their release.

Description Local authorities will be given powers to evict anyone living or camping on any land which is not their own. Failure to comply or reentry upon the land within a period of three months would be a criminal offence.

The duty of councils to provide

safe caravan sites for travellers, which has existed since 1968, will be removed and grants for these sites will no longer be available.

Criminal damage to property is now to include "damage to the land itself", a provision suggesting that those who cannot be proved to have damaged "pieces of string" may be accused of damaging blades of grass.

This legislation can turn those who have nowhere to go, whether they live on roadsides, abandoned fields or contaminated industrial wasteland — into imprisonable criminals. It also reinforces the rights of owners to manage their properties in ways that may not be

in the public interest.

At present, the rights of the state or of wealthy owners to alter their property in the face of public interest (say, by felling trees or constructing roads) are protected by the practise of planning law. Objectors are not entitled to legal aid to contest planning applications. Fighting applications requires money, and it is usually only property owners who can afford to do so.

Inequitable though this might be, it does make some sense. Legal aid for every planning application would compound bureaucracy and impose an onerous burden on the taxpayer. Furthermore, until now, a sufficiently enraged public has had an ultimate extra-legal resource—the right of public, peaceful protest

upon the site.

This right should not be underestimated. It has provided collateral for respectable bodies lobbying in the public interest. Many of the most august defenders of the environment gained their initial impetus and their subsequent status from acts of trespass or worse. The Commons Preservation Society in 1866 ripped down enclosers' fences and thereby saved Berkhampstead Common, Epping Forest, the New Forest and many other landscapes we now take for granted. The society still exists as the Open Spaces Society, while several of its leading members went on to found the National Trust. Similarly, the Ramblers' Association owes its reputation, above all, to the famous mass trespass on the moors of Kinder Scout in 1932.

Under the proposed legislation, the participants in these actions could have been convicted as criminals and imprisoned. So, too, could all those who took part in the recent anti-motorway demonstrations at Twyford Down and the M11, which are forcing the Government to reconsider its road programme. Democracy springs not from the barrel of the gun, nor even from the ballot box but from the understanding that people, when incensed, have a right to put a spanner in the works of a remorseless legal machinery without risking imprisonment or being mown down in a hail of bullets.

The Government's attack on "public order" has so far elicited an uncoordinated response from the organisations representing those most affected. The most vigorous lobbying against the criminal trespass measures has come from a few groups representing travellers, ranging from Save the Children Fund to small regional groups. Liberty, the civil rights organisation, has been a consistent voice against the bill. Squatters' groups have tried to muster opposition, but have been hampered by lack of funds. The Green Party is divided over the issue and environmental groups have hardly breathed a word.

There are reasons for this reticence. Those targeted by these measures — travellers, gypsies, squatters, marginals — tend not to elicit press or public sympathy. Visible support for these people may deter potential donors or even place an organisation's charitable status in jeopardy. It may be for this reason that two large and well-known charities are apparently axing their trav-

ellers' units.


Ironically, some of the loudest opposition is coming from the Police Federation, concerned about being in the invidious position of having to decide who is a bona fide member of society marooned in a lay-by and who is a genuine vagabond.

The proposed measures will affect a broad spectrum of British society, from Friends of the Earth to the caravan Club, the Ramblers' Association to hunt saboteurs, from Shelter to the M11 squatters. Such groups would be well advised to forget their political differences or reservations and unite in a broad front to combat the legislation. If they don't, we may live to regret it.

Deep acidic cheese gratings sprinkled on bass driven up for it UK tinged houser. Female vocal sounds suspiciously like a cross between that singer in Blue Pearl and Heather Small from M People. Harder, trancier flip only adds to package.

9.ROLLO GOES CAMPING-Get off Your High Horse (Cheeky)

Cheeky high camp it most certainly is. Great fun (and isn't that what we want?) on the dance-floor. Big production, cheesy pianos, fuck off breakdowns and a smile inducing factor of, ooh, 10 will guarantee success. Nice one Rollo!

10.BLACK LABEL-Tracks for Working DJ's (Black Label)

No info at all on this so it's very mysterious. What it is is a strong four tracks of superior cut 'n' paste Cleveland-esque grooves with a generous sprinkling of all those magic ingredients that work well on the dancefloor. No real groundbreaking ideas but a solid DJ tool. Who are you?

11.GASTON-Touche (White)

Mystery white (aren't they all?) with Gaston casting off Rene for a wierd extended excusion on the cutting edge of frontier house utelising smokey jazz club vocal samples. Very interesting and very good.

12. UNITED STATES OF SOUND-Oscillator (Bomba)

Rumoured to have worked on this track for over a year (according to the press release) the Glascow duo do Bomba a big favour with a big tune that could fit into a good cross section of discerning DJ boxes. Stretching the trance envelope.

13. PATERSON AND PRICE-Audio Lemon EP (d.disc)

New Glascow based label kicks off with a tough US sounding track with two moody mixes.

14. CHAPTER 9-Feel Free (ouch!)

Harder edge with some back catalogue N 'n' R vocal samples. Peak time, after the watershed, chicken flap groove outa London no less.

15. LEX LOOFAH-Freaky Deaky (Warp)

John Gilpin produced house friendly acidic romp on "more bounce to the ounce" mix. "Step Off" omits acid and loosens up the mix for a high skip factor. But it's "Ooh la la" that toughens it a tad and is, goddamnit, more fun than the other dour-faced mixes.

16.WORK(White)

No info on this but nevertheless a very good full on Euro house with a lot of nice touches. A fine example of UK house leading the world field.

17. HOUSE 11 HOUSE-Crin' for More (Planet Love) Ger.

Flip for 'Did You Ever Ask Me' and find some trance house of the highest magnitude. A melancholy feel only adds to its depth.

Loved up or fucked up?

18. MAYHEM LEO SOUND VOL 1-Move Your Body (Snook) It.

Move Your Body as a hook has been used a little exessively but here's a worthwhile variation. The dub (don't even think it!) is of coarse the one. Soulful, lots of space, and does the damage late AM.

19.QUADROPHONIA-Warp Factor One (ARS)

Fuck off breakdown of the year so far. It's cavornous, immense, bigger than the Grand Canyon and you free-fall for a thousand miles before...

20.SOLAR ECLIPSE-Human World (After 6AM)

Breakdown of the year so far part 2. However, this is from a different direction. Gentle bass pumps while a clarinet (?) trances it out.

21.DIGITALIS-Shine the Light (Six)

A, erm, Top groove. Pianoes to swoon for (tucked in right at the end and completely unexpected.) The floor goes apeshit with those little up and down piano type movements of the right hand that, you know, everyone does when the piano comes in. (Shut up you casualty). It's a laugh anyway.

22. YOUNGER THAN PARK-Can't Turn Back (Serious Grooves)

Serios Grooves have completely lost the plot if they think that DJ's (the biggest buyers of dance vinyl) are interested in 10" limited edition coloured vinyl (oatmeal? pur-leaze!) "for collectors only". It indicates a measured sign of desperation that their confidence in the track is seriously lacking. However Terrence Parker and Claude Young Jr. have nothing to worry about. Side 1, Claudes mix, is seriosly mediocre. Flip for T.P.'s Funk You Up Mix and you are in bass line heaven. Hearing this on a big system is to experience something that could only be described as a musical second coming. A minor gem and no mistake.

23. LISA B-You and Me (Cleveland City Remixes) (FFRR)

Shock, horror, probe! Lisa B in good remix shock. Horror as it is Rhyme Time who do the do. And a probe for the person who decided not to release this. Lisa's vocals are stripped and sparingly sprinkled around usual Cleveland groove.

1.SLAMM PROJECT-Jump "Chico" Slamm (Cajual) US Four totally different wierd and wonderful mixes to choose from.

2. LECTROLUY REMIX PROJECT-(Eightball) US

Yes, believe the hype. Well worth the £11.50 price tag if you can get hold of this double pack. Junior Vasquez at the helm, doing the business.

3.4TH MEASURE MEN-MK Remixes (Area 10)

Kinchen in typically deep and simply devastating form. Heavenly. 4. ORANGE GROOVE KREW-Miami Rush Hour (Multi Trax) US

Laid back tribally tinged jams. Makes you want to hit the beach on a moonlit night and party with the ocean lapping the shore.

5. CAUCASIAN BOY-Honeypot (Strictly Rhythm) US

A beautiful sunny day armlifter of a record. Mellow but uplifting. Nice acid twiddlings on reverse retain mellow edge.

6.MANGOHEAD-(Nitebeat) US

Four mixes ranging from seriously tribal US house to just tribal. Well worth a listen.

7.R.A.W.-Unbe (Strictly Rhythm) US

The Italian remix does the damage. Again a tribal excursion to someplace nice.

8. LIBIDO-Can't Handle (Strictly Rhythm) US

Title track the one. Very trancey feel. Other tracks get quite hard.

9. TOMBA VIRA-La Mandarina (Global Cuts)

Unusual sounds galore. Very reminiscent of that Renee and Gaston track (but that's probably because it's licensed from Fresh Fruit.)


10. YOUNGER THAN PARK-Can't Turn Back (Serious Grooves)




3. CODE OF PRACTICE GOVERNING POLICE POWERS
